LOCAL LAW NO. \_\_\_\_ OF 2021 TO AMEND THE HENRIETTA TOWN CODE AT CHAPTER 273 TO LIMIT PARKING IN CUL-DE-SACS

BE IT ENACTED, by the Henrietta Town Board, Monroe County, State of New York, as follows:

### Section I. Authorization

The adoption of this Local Law is in accordance with Section 10 of the New York Municipal Home Rule Law.

## Section II. <u>Title and Purpose</u>

This law shall be known as and may be cited as Local Law No. \_\_\_\_of 2021 of the Town of Henrietta. The purpose of this local law is to amend the Henrietta Town Code at Chapter 273 to limit parking in cul-desacs in the Town of Henrietta.

## Section III. <u>Legislative Finding</u>

The Henrietta Town Board finds and hereby determines that, for purposes of traffic safety, parking in culde-sacs shall be limited.

### Section IV. Amendment.

Section 273-6 shall be amended to add the following subsections:

- 55) The circle on Gloucester Circle
- 56) The cul-de-sac on Rodlea Circle
- 57) The cul-de-sac on Holiday Road
- 58) The cul-de-sac on Finucane Road
- 59) The cul-de-sac on Compton Crescent
- 60) The loop on Blind Creek Circle
- 61) The cul-de-sacs on Navajo Circle, Pueblo Circle, Chieftain Circle, Chippewa Circle, Blackhawk Circle, and Buffalo Horn Circle
- 62) The cul-de-sacs on Green Moor Way, Green Isle Road, Green Adler Park, and Green Acorn Lane
- 63) The entirety of Green Clover Drive, including the dead-end
- 64) The cul-de-sac on Lovelace Lane
- 65) The cul-de-sac on Colonnade Drive
- 66) The cul-de-sac on Hillbrook Circle
- 67) The cul-de-sac on Southern Hills Circle
- 68) The cul-de-sac on Silverberry Road
- 69) The traffic circle of Red Creek Drive
- 70) The cul-de-sac on Yosemite Circle
- 71) The cul-de-sac on Linhome Drive
- 72) The northern hammer-head on Tylerton Way
- 73) The cul-de-sacs on Coneflower Drive, Sweet Alysum Drive, and Blazing Star Circle
- 74) The hammerheads in Riverton including Anemone Lane, Beakrush Lane, Buttonbush Lane, Foxglove Lane, Pumpkin Hook, Stargrass Lane, Sundew Lane, Yarrow Hill, Hepatica Lane, Mayapple Lane, Meadowrue Way, and Phlox Lane.

# Section VI. Repeal, Amendment and Supersession of Other Laws

All other ordinances or local laws of the Town of Henrietta which are in conflict with the provisions of this local law are hereby superseded or repealed to the extent necessary to give this local law force and effect during its effective period.
