
**CERTIFICATE**

***To the Town Clerk of the Town of Henrietta, County of Monroe.***

This is to certify that the undersigned County Superintendent of Highways will close a section of highway in the *Town of Henrietta, County of Monroe, known as Winton Road, between Goodway Drive and Brighton Henrietta Town Line Road*

It is necessary to close that portion of highway effective *October 31, 2021 at 9:00 AM for approximately one (1) week for railroad crossing repairs*. Under the provisions of the Highway Law, the work cannot be properly conducted and completed unless the portion described be closed during the time such work is in progress. Please notify your Town's police, schools, fire department, ambulance and post office of this closing.

***To the Superintendents of the Town of Henrietta, County of Monroe:***


A certificate, of which the foregoing is a copy, having been executed by me under the authority conferred by Section 104 of the Highway Law and filed in the Office of the Town Clerk of the *Town of Henrietta, County of Monroe, New York*.

You are hereby notified that the above-described section of highway will be closed by me effective *October 31, 2021 at 9:00 AM for railroad crossing repairs*, and the traffic will be detoured in the following manner:

**DETOUR:** Jefferson Road (NYS Rte. 252); East Henrietta Road (NYS Rte. 15A) and Brighton-Henrietta Town Line Road

**Notes:** The road will remain open to local traffic only up to the railroad tracks.
