From the Supervisor...

We are starting to see the light at the end of the tunnel for our year long pandemic thanks to herculean efforts to vaccinate anyone and everyone who wants a vaccine. I have heard good things about the operations of all of the vaccine centers, but especially for the operation at the Dome Arena. The State has this running extremely efficiently and the Town has been helping wherever we

can. We are working with the State to improve the traffic flow as sometimes, the traffic can spill out onto East Henrietta Road. Towards that end, the East Henrietta Road entrance may become entrance only, allowing cars to form two lines going in. We will put signage where Fair Avenue meets Calkins Road should that become the case.

The COVID Relief Act passed and it includes money to reimburse the Town for additional COVID-related expenses, supplement our revenues to make up for tax revenues lost to the pandemic, and additional dollars for sewer or water infrastructure. We are putting together a plan, but will most likely use the infrastructure dollars to bring water service to a few areas that do not have it, especially those areas using wells that are near industrial areas.

This past winter, our new plow trucks and additional Highway personnel paid off as we were able to clear the streets faster than ever before. We were also helped by a relatively mild winter, snow storm wise, but when we did have the few storms, our snow clearing was very efficient thanks to the new routes created by the Highway Department to take advantage of the new capacity. I intend to keep adding personnel to ultimately reach the goal of being able to have a full crew clearing the main roads and simultaneously having a half crew clearing the side roads. This would become essential during a prolonged heavy snowfall.

From the Supervisor...

One of the issues as we continue to add Highway personnel is what do those individuals do during the rest of the year. These past few years, they have been catching up on a backlog of catch basin repairs, but we are nearly caught up. One thing we are exploring is the potential of doing leaf and brush pickup during the fall and spring. It is a time consuming process, but if we have added enough personnel to achieve our snow removal goals, then we ought to be able to offer that service during.

We are continuing with physical improvements to the Town Hall Campus. We are in the process of building a new Sewer and Drainage garage to house that department's equipment. In addition to being able to have all of their pump trucks, camera trucks, and other equipment housed in one location, this will also free up much needed space in the Highway garage. And we are building a small pole barn structure to house equipment for the Facilities and Grounds department. So please excuse the construction fences when coming to the Town Hall Campus.

We have begun drafting our Local Waterfront Revitalization Program (LWRP) plan. The centerpiece will be a riverwalk trail connecting to the trails the Renaldis put in at their Riverwood Tech Campus facility and continuing all the way down into Rush as they are partnering with us on the project. There will also be canoe and kayak launches as well as other improvements. If there is an idea you would like to see to revitalize our waterfront, please send it to me at supervisor@henrietta.org and I will bring it to the Waterfront Advisory Committee that has been formed to help put the plan together.



We have been continuing to do the Foodlink distributions, although I am unsure how many more there will be. The Town Board has put in a number of new initiatives designed to increase open space, encourage the reuse of existing buildings, and manage the growth within the Town. It has been exciting to see some of these new initiatives being put to use, including:

Mixed-Use Revitalization Districts: these districts were created to try to revitalize some of the "tired" retail portions of Town and allow them to be repurposed for mixed use development. Marketplace Mall has taken advantage of this new Town Code to add the URMC Orthopedic Center as well as a new affordable Senior Housing project, all within the bounds of the existing Mall property.

Mixed-Use Employment Districts: when we removed multi-family housing (apartments) from industrial and commercial zones, we by law had to provide new areas they could go. In addition to the revitalization districts, we also added Mixed-Use Employment Districts with the intent of developers creating office parks intermixed with apartments allowing those who wish to walk or bike to work nearby can do so. Two new projects are proposed for south of RIT that make use of this new Town Code.

Conservation Clustering: We are not, by law, allowed to totally prohibit development, but we can require it fit with the surrounding area. And so we've been updating the Zoning Code with respect to the Rural Residential areas south of the Thruway to encourage the preservation of open space. A recent project for 46 new homes preserved a roughly 50-acre farm and 30-acre park under this new Town Code.

Transition Buffering: We also now require new projects to have increased buffering between them and existing properties to help reduce their impacts and this has been well received by neighbors of new projects.



Town Hall Access During COVID



As we did all year, we will strive to keep Town Hall open during the pandemic. Here is some important information should you need to visit Town Hall to pay taxes, obtain a building permit, or conduct other business.

- If you are running a temperature or have any other symptoms, please do NOT visit Town Hall. Instead, conduct your business through one of our drop boxes or by phone, email, or on the web.
- If you are going to visit Town Hall, you MUST wear a mask while inside the building.
- We have made the lobby doorways dedicated entrances and exits so as to minimize cross traffic.
- During busy times, a Town employee will greet you, ensure you are masked, and scan your temperature — if your temperature is over 100° you will not be permitted into Town Hall.
- When waiting in line, please maintain 6' separation between parties. Stickers have been placed in the lobby to help guage the distance. Also, please wait outside the inner doorway until called.
- If the County moves to higher pandemic conditions, such as orange or red, we may switch to conducting business only through the service window or through drop boxes.
- During slower times, you may need to ring the doorbell outside the inner doors to get service.
- When waiting to enter the inner service areas, please stand clear of the doors as they open automatically. A sticker shows the swing of the door.
- An external secure drop box has been installed just to the east of the eastern exit. It is available 24-hours a day and may be used for tax payments and other business. All deposits received after business hours will be collected and time stamped at 9:00 AM the next business day.
- An internal drop box has been installed just inside the western entrance and may be used during normal Town Hall office hours.
- There are carts inside the lobby for dropping off or picking up drawings from either the Engineering or Building departments.

2020 BUDGET YEAR IN REVIEW

2020 saw a large drop in sales tax revenues, but we were able to cut expenses to offset those losses and we delayed a number of major capital outlays until we had a better financial picture moving forward. Most of those capital outlays were restored in the 2021 budget. Other savings occurred due to facilities and programs that were shutdown, although the Town worked hard to ensure all fulltime employees remained working.

2020 MAJOR EXPENDITURES

Most of the major expenditures in 2020 had been committed to prior to COVID and were completed. The Veterans Memorial Park culvert and Hylan Drive sidewalk were delayed until this year. The West Wing renovations have helped serve residents and businesses. We made additional improvements to Town Hall to help keep employees and residents safer during the pandemic, including the addition of service windows and drop boxes.

FUND BALANCES OF MAJOR FUNDS

Our cost cutting and delaying of capital outlays meant that we were able to keep our fund balances in tact, and the funding from delayed projects allowed to carry over the fund balance into the 2021 budget such that we were again able to avoid raising taxes for a second straight year. We budgeted 2021 conservatively, but should be able to restore some of the projects cut due to COVID thanks to the funds from the COVID relief bill.

New Town Court

We are nearly complete with the plans for a new Town Court and are now applying for grants to help get the Court built with minimal cost to tax payers. The Town pays rent for its current court so those costs would be applied to any debt service incurred. We expect to go to referendum this fall for construction in 2022. The goal is to create no tax increase from the project, but that will be dependent on available grant funding.

State of the Town Address

2021 ADOPTED BUDGET

With an uncertainty in future revenues, we eliminated a number of projects from the budget and drew on our strong reserves in order to hold the Tax Levy flat from 2020, meaning there were no new Town taxes for this year. Because of growth in the Town, the tax rate actually DROPPED by 8.5%!

Note that debt did not increase, but since the overall budget is smaller, the percentage went up slightly. Capital outlay and projects are down a lot.

2021 MAJOR EXPENDITURES

We are completing the second entrance into Veterans Memorial Park and moving forward on the Hylan Drive sidewalk. We are also building a new garage for our Sewer and Drainage equipment and a smaller garage for our Facilities and Ground equipment. We are nearly done adding a three seasons room onto the Senior Center. And we are continuing our growth of the Highway Department to allow for faster plowing.

COVID RELIEF ACT FUNDS

The COVID Relief Act includes funds directly to Towns to offset the effects from COVID. Our initial estimate is that we lost roughly \$1,500,000 in revenues due to the pandemic. We also will be reimbursed for roughly \$450,000 in COVID related expenses that were not reimbursed from previous acts. Henrietta will also receive an additional \$2.3M, mostly in 2022, for infrastructure related projects. Note these are early estimates only.

COVID RELIEF ACT PROJECTS

The COVID Relief Act allows the direct funding to Towns to be spent on improving water and sewer infrastructure in the Town. We are very early in the process, but we are exploring bringing water to portions of Town currently lacking, including parts of: Middle Rd, Telephone Rd, Williams Rd, Tobin Rd, Rush-Henrietta Town Line Rd, and others. If there are funds left, we will look at offsetting sewer installations for R-1 neighborhoods lacking them.

CHANGES TO TOWN CODE 2020

In 2020, we began a supplemental Generic Environmental Impact Study (SGEIS) to add new Solar Regulations and to add Incentive Zoning. We have had our first 25-acre/5-Megawatt Solar Array approval under the new regulations - they are only allowed on working farms and cannot occupy more than 25% of the acreage. Incentive Zoning will encourage reuse of old buildings, preservation of open space, and other community goals.

CHANGES TO TOWN CODE 2021

We are working on updates to sections of Town Code for driveways (to allow for turn arounds and greater widths outside the right of way), signs (to clean up issues that always lead to variances), enforcement (to allow us to go after the direct violator and not just the property owner), cannabis (to align with the new State laws), ethics (new ethics board rules), plus assorted clean-up of code we've experienced issues with.

REUSE OF EXISTING BUILDINGS

The Town has emphasized reuse of existing buildings through zoning changes (revitalization overlay districts) and code changes (incentive zoning) and developers have responded. Major reuses include the former Circuit City (now Life Storage), former Wonder Bread/Hostess (now Namaste), former Sears (now URMC), and former Delphi (now RGH), as well as countless restaurants and stores.

MAJOR DEVELOPMENTS IN 2021

2021 has started quickly with regards to new development, including 13 public hearings in one night. Multiple new housing projects are proposed, including an affordable senior housing project at the Mall. Multiple industrial projects are slated for south of RIT and elsewhere, and new retail and restaurants continue to be added to Town. New Town Code requires these projects to have more green space and buffering to existing properties.

A Word from the HFD and MCSO

HENRIETTA FIRE DISTRICT WELCOMES A NEW CHIEF

It has been a very busy year for the Henrietta Fire District to date. Even with a COVID related slow down, still handled over 4,000 calls last year and are on pace to surpass that this year.

This past January, Chief Mark Strzyzynski retired from the Henrietta Fire District after 5 years as the fire Chief and 32 years total in the fire service. We can't thank him enough for all he has done for the district, town residents and its visitors. Taking over as the District Fire Chief is former Assistant Chief Mark Cholach. Chief Cholach previously worked for the Monroe County Fire Bureau and was the Chief of the West Webster Fire Department. The District promoted Captain Mike Dinsmore to Assistant Fire Chief. Chief Dinsmore, aka fireman Mike, has been the leader in the Town's fire prevention programs, reaching thousands of school children, seniors, and businesses every year.

The District has hired 8 new firefighters, who are being trained, along with 16 other new firefighters, in a fire academy being run by the Henrietta Fire District, saving the District thousands of dollars. Upon graduation, another round of promotions will take place, creating a Battalion Chief for each of the 4 shifts, culminating the district's long range plan to build out staffing for additional engines and a building of a new Station 6, meeting national standards for firefighters on scene within the first few critical minutes of a fire. We've not just added career firefighters, we have taken in 17 new volunteer firefighters. And we are always looking for more volunteers. If interested, please see the ad on Page 19 of this newsletter.

Finally, construction is expected to begin soon on the new Station 6 with an anticipated move-in date of late spring, 2022. Stay tuned to all of our social media outlets, including Facebook, Twitter, Instagram, and Nextdoor to learn all things Henrietta Fire including calls, meetings, safety tips and news. Also, keep checking out our website, Henriettafire.com as it is going through a major overhaul with a new look and information!

MONROE COUNTY SHERIFF'S WARNING ABOUT THEFTS AND SCAMS

While we all love this time of the year, with the chance to finally open the windows and get out and enjoy the warmer weather, we'd like to take a few minutes to remind you how to keep yourself from becoming a victim of a crime. We continue to receive reports from residents who are having items stolen from their vehicles. As a reminder, please remove all valuables from your vehicle and lock your vehicle even if you are home. Also, please remember to close your garage door while not outside to prevent thieves from stealing items from your garage.

We have also seen an uptick in scam reports being reported to MCSO. Some of the most common include receiving a call from

a "Government Office" stating that you owe money, that your friend/family member is in trouble out of state and needs bail money or that your computer is infected. Most of these scammers will ask you to purchase gift cards to resolve the situation. A big clue that this is likely a scam, the sender asks you to purchase gift cards and read the number over the phone. Legitimate businesses/government agencies would not ask you to pay with a gift card. Last word of advice, don't answer the phone if you don't know who is calling! Stay safe and enjoy spring.

fishing weekend is a great opportunity to try it out for the first time or, if you haven't gone in a few years, to remember the pleasure of fishing once again – especially if you've been cooped up in the house!

After the Free Fishing Weekend, those over the age of 16 need to have a fishing license. For New York State residents, annual fishing licenses cost \$25.00 for ages 16-69 and \$5.00 for ages 70+. You can purchase fishing licenses the Town Clerk's Office during regular office hours, Monday through Friday, 9 a.m. to 5 p.m. You may be eligible for a free or reduced fee license if you are active-duty military or a military veteran with 40% or more service-related disability. POTHOLE FILLING ON TOWN, COUNTY, AND STATE ROADS

Winter has no doubt left potholes. Most complaints we receive are not actually on Town roads but are on State or County roads. The three numbers to know, depending on where you are:

For potholes on State Roads (Thruway, I-390, Jefferson, East Henrietta, West Henrietta, Lehigh Station east of West Henrietta, and Erie Station west of West Henrietta) please call the **NYS DOT** at **1-800-POTHOLE** and report it.

For potholes on County Roads (most major roads that are not listed above), please call the **MC DOT** at **585-753-7700** and report it.

For potholes on any side street, please call the Henrietta DPW at 585-359-7005 and report it.

In all cases, please note the street location and which lane(s) it is in.

LEAF AND BRUSH DROP OFF HOURS

2021 TENTATIVE ASSESSMENT ROLL — AVAILABLE ONLINE MAY 3RD

The tentative assessment roll will be available online for the public to view on May 3rd.

If you do not have access to a computer or the internet, feel free to call the assessor's office directly at 359-7032 for tentative assessment information.

THE ASSESSMENT PROCESS — FIELD INSPECTIONS

Our goal and purpose is to maintain a fair and equitable assessment roll. To achieve this goal, the Assessor's Office continually reviews real estate sales and analyzes neighborhood property values throughout Town. One of the ways our assessment roll is maintained is through field inspections. This helps us keep property inventory records current. We also review and inspect new construction, demolition, or property improvements throughout the Town. Accurate property information is crucial to maintaining a fair and equitable assessment roll each year.

Once the weather improves, field inspectors will be physically inspecting properties, measuring structures and updating photo files in several neighborhoods throughout the spring and summer as weather conditions permit. During these field inspections, if no one is home, we'll leave a bright yellow "door tag" with a phone number to call. Please call the office to confirm your property information if we have left a door tag. Field inspectors will always have a Town of Henrietta photo identification badge.

THE ASSESSMENT PROCESS — THE GRIEVANCE PROCESS

From May 3rd through May 25th, property owners who do not agree with their assessment may contest their assessment by filling out a RP-524 grievance application as well as the Market Value/Condition Issue worksheet and submitting them to the Assessor's Office. These forms will be available in our main foyer area of Town Hall, on our website, or you may call 585-359-7032 we will mail them to you.

The application and worksheet aid residents in understanding what the grievance process entails and the type of information to collect prior to submitting a grievance packet. The first side of the worksheet allows residents to propose three different comparable properties - these should be properties that are listed in the **Town of Henrietta Sales Book**, available on our website at www.henrietta.org/assessorsoffice or at Town Hall, as this is the full list of sales that can be used as comparables deemed "marketable" per NYS guidelines. The second side of the worksheet allows residents to provide information regarding the condition of the property that may be different than what is represented on the tentative role. There are a number of conditions that can affect a property's assessed value, such as a damaged roof or major structural issues, which can be addressed on the worksheet.

All applications are due to our office no later than 8:00 PM on Tuesday, May 25, 2021. When an application and all supporting documentation is received an appointment will be set. Once completed and received, the worksheet provided will give both the Board of Assessment Review as well as the Assessor a clear picture of a resident's specific grievance to help determine if the tentative assessment is an accurate reflection of market value or needs to be adjusted.

PLEASE NOTE: THE TOWN GETS NO ADDITIONAL TAX DOLLARS BY RAISING YOUR ASSESSMENT

A change in assessment changes the size of your slice of the tax dollars collected, but does not change the overall amount we collect. That is set in the Budget, irrespective of assessments.

If they are really old, you may want to replace the entire detector.

BUILDING PERMITS - PLAN AHEAD SO YOU ARE NOT DELAYED

Life safety is the primary reason for the permitting process as well as the protection of property values. If you have any questions concerning construction projects that you can't find the answers to on our web page, please contact us at 585-359-7060. As a reminder, if you are selling your home, the financial



institutions will want to verify that any improvements to your property were done properly and inspected by way of Building Permits. Remember to plan ahead for those Spring and Summer projects that require permits from this Office. Our typical permit review lead time is approximately two weeks; however, this is our busiest time of the year, so the sooner you call, the sooner you can get started on your project. Please call for assistance if you feel your particular project doesn't match up to any of the categories listed on our Application to see if a permit is required. Engineering & Planning

DESIGN OF NEW TOWN COURT

Work is well underway for the design of the new 12,000 square foot Town Court. This exciting project is being designed by Bergmann Associates and will have two court rooms, enhanced security, better traffic flow, and many other features. Like in past years, the Engineering Department will be designing the site plan for this project. The initial rendering can be seen above.

CONSTRUCTION OF NEW PUBLIC WORKS GARAGES

In order to meet the need of our growing Department of Public Works, the Town has hired the firms of Meagher Engineering and EC4B Engineering to assist with the design of a new 70' by 150' sewer and drainage garage. This new facility will replace a dilapidated smaller building and will give us a new home to store our two flush trucks and other vehicles. The project is anticipated to start construction in the mid spring and be completed by late fall. Also included is a second smaller garage for grounds equipment.

CHILTERN ROAD DRAINAGE IMPROVEMENT PROJECT

A portion of Chiltern Road regularly floods during heavy rains. The Town has received a \$125,000 Community Development Block Grant from Monroe County to help cover the cost of installing a parallel storm sewer along Chiltern Road, along with other drainage improvements within the subdivision. The project will be designed by the Engineering Department and we anticipate this work being started sometime this summer or fall.



2021 SANITARY SEWER AND LATERAL REPLACEMENT PROGRAM

The Town is continuing to replace old Orangeburg Pipe laterals throughout the older portions of Town. This year Clearview Drive and Williamsburg Road will have all fifty-three laterals replaced. The project was designed by the Engineering Department and is being constructed by Lammes Construction with the work scheduled to start in late April and completed by the end of September.

LEHIGH STATION ROAD SANITARY SEWER PROJECT - PHASE 2

The Town has applied for a Monroe County Community Development Block Grant to help offset the cost of extending the sanitary sewer along a stretch of Lehigh Station Road where there are none, adding to what was installed last year. If the Town gets the grant, we will design the new extension of the sewers.

TINKER HOMESTEAD CARRIAGE HOUSE RELOCATION PROJECT

A resident located on Lehigh Station Road has been kind enough to donate their 1800's carriage house to the Town. The 20' by 25' two story carriage house will be dismantled and relocated to the Tinker Homestead. The original Tinker Homestead carriage house was demolished many years ago so the relocated carriage house will be a welcome addition.



CONTINUATION OF SIDEWALKS AND CULVERTS PROJECTS

A number of projects were delayed due to COVID, including new sidewalks along Hylan Drive and East River Road as well as the new culvert in Veterans Memorial Park that allows for a second entrance into the Park. These projects are now moving forward again, along with Pump Station upgrades and numerous additional large projects, keeping the Engineering Department busy with the Town's projects in addition to reviewing all of the plans that developers are submitting during this busy construction period.


