From the Supervisor...

Once again, the amount we collect in property taxes will be the exact same amount. In other words, there was **NO INCREASE** in Town taxes. And thanks to the growth in the Town, that means the tax rate is now at a record low of approximately \$1.06 per thousand of assessed value. The previous record low was \$1.11 per thousand.

Unfortunately, while most other taxing jurisdictions have

also kept their tax levy increases low, the same cannot be said of the Fire District. While their budgeted expenses were held flat, the tax levy will increase by 15.6% as last year they had applied a large amount of non-recurring funds to the budget and those were no longer available. So your taxes may go up, but not because of the Town. Our Directors have worked hard to increase services while holding expenses down and as such, the increases in sales and mortgage taxes are able to cover the growth in expenses in the Town. Loss of a Community Leader

Sadly, RIT, Henrietta, and the greater Rochester area lost a leader and great human being November 13th when Dr. Barry Culhane passed away. Barry was a mentor and close personal friend of mine and I would not still be in Rochester if it were not for his assistance in my early days in college. Barry was also a surrogate father for me as my own

father had passed away when I was 17, just before I came to RIT. Barry helped me through some difficult times, gave me a full-time job when I was out of money to attend school, and provided support and encouragement in my future endeavors.


For the community, Barry was tireless in his commitment to veterans and was instrumental in the creation of the Vietnam Memorial in Highland Park. He also started the Veteran's Breakfast at RIT that welcomes those who serve from across the community. Barry was also the driving force behind the ImagineRIT festival that highlights innovation at the school and provides a wonderful event for kids and adults from all across our region. Barry has touched countless lives and he will be greatly missed. My heart goes out to his wife and family and all those hurting from his sudden departure.

The Need for Judicial Reforms

The Monroe County Supervisors' Association, for which I am currently serving as President, wrote a joint letter calling for judicial reforms. Unfortunately, this is a politically charged topic when it should not be. Some of that is due to misconceptions. Some of that is due to the overly political nature of our country right now. First, I want to address one of the major misconceptions: Bail Reform.

The issues we are seeing with dangerous people on the street is not due to Bail Reform. The purpose of bail is to make sure someone shows up for trial. If bail is set, and someone pays it, they are out on the street. Bail reform was needed because what was happening is that people with money could be free while people without money had to spend time in jail awaiting their trial.

fall through the cracks and people to be harmed in the process.



I understand that there were cases where this was abused. Then fix that. Have a means to review, discipline, and even remove problematic judges who routinely violate the constitution, especially with regards to people's rights. Create a faster review and appeal process to overturn those bad decisions. But don't take discretion away from all of the judges.

All across the nation, crime is on the rise. Add to that staffing issues at police departments and at the District Attorney's Office, plus greater work required per case due to shorter timelines for discovery with no ability for the judge to extend the timelines, and you have what at least feels like a full-blown crisis. The last judicial reforms cleaned up some inequities in the system, but appear to have overcorrected. It is time to fix those overcorrections. Politicians need to work across the aisle and store across the political spectrum to come together on common sense reforms.


2022 YEAR IN REVIEW

After an initial winter COVID spike, 2022 was a "return to normal" year with most programs back in full swing, albeit with some additional procedures and safeguards for those vulnerable to respiratory diseases like COVID or flu. While inflation has been high and supply chains still stressed, both of which have added to the Town's expenses, revenues have come roaring back keeping us in the black.



PLANNING FOR 2023

2023 includes a large capital expenditure for a much-needed new Town Court – currently, we are renting a court facility, which is wholly inadequate, especially from a security standpoint. The funds are coming from ARPA funds and our own fund balances, so we do not anticipate having to spend any property tax revenue or bond any portion of the costs. However, we did approve up to \$2M in bonds, in the event we need it due to rising costs. Debt service on those bonds would be less than we are paying in rent, thus still saving us money.



New Park for the West Hamlet



NEW PARK CELEBRATES THE HISTORY OF WEST HENRIETTA

If you've been through the historic hamlet of West Henrietta lately, you probably noticed some recent changes. Two residents dedicated to preserving the historic charm of the neighborhood have been hard at work, creating a beautiful space to be enjoyed by everyone.

Ann Stevens and Bill Shattuck approached the Historic Site Committee and the Town Board with plans to purchase the property on the southeast corner of West Henrietta and Erie Station Roads with the goal of creating a park to celebrate the history of the hamlet. Both the committee and the board liked the idea so an ad hoc committee was formed, including the Town Historian, members of the Historic Site Committee, the Parks and Rec Advisory Committee, and other Town officials, to create a conceptual design for the park. Ann and Bill purchased the property in 2021 and began making significant improvements with the intent of donating those improvements when the Town purchased the property from them for their purchase price.

The name Chapman's Corner honors the Chapman Family that owned the property for 189 years. The Chapman House was the first inn built in West Henrietta. Bill has replicated the inn, in miniature form, to be used as a Little Free Library in the park (see picture on right).

Dead trees and shrubs were removed and new trees added to those original plantings remaining on the property. Many grand trees that provide shade and add to the parklike setting were saved. The biggest change was the revitalization of the former Three Sisters Ice Cream stand into an attractive informational pavilion where visitors can learn all about the history of the West Henrietta Hamlet. Paying homage to the former Three Sisters Ice Cream, local sculptor Stacey Mvra has created an ice cream cone themed bench and bike rack, pictured right.

Once the land transfer is complete, the Town will dedicate the new park as Chapman's Corner Park and will make improvements to the parking lot, add a restroom and a small playset, as well as other enhancements. The Town is grateful to Ann and Bill for their dedication and generosity for the improvements they have made over the past two years. Visit Chapman's Corner Park in the Summer of 2023 to enjoy the park and learn more about the rich history of the area.


TINY ART SHOW

PAYMENT OPTIONS

PAYMENT IN FULL

- Pay in full by deadline of February 10th, with no additional interest.
- After the February 10th deadline, interest accrues at the rate of 1.5% per month.

INSTALLMENT PAYMENTS

- The first installment is due on or before February 10th, with no additional interest.
- The amount of interest owed on installment payments is based on the date the payment is made. What that means is that there is no interest on ANY payments made on or before February 10th it doesn't matter whether you're paying the 1st, 2nd, 3rd, or 4th installment. Conversely, there is interest on ALL payments made after February 10th, regardless of which installment is being paid.

If you're looking at the installment stub, the amount due is the correct amount as long as you are paying within the date range listed. Let's use the third installment as an example:

- if you're paying between March 1st and 31st, you'll owe the amount shown.
- if you're paying BEFORE March 1st, you'll owe less interest.
- if you're paying AFTER March 31st, you'll owe more interest.

Additionally, even though there are data ranges listed on the installment stubs, you can make those payments anytime within the total tax collection period. Sticking with the third installment as an example, you do not have to wait until March 1st to make a payment. If you have the means to pay earlier, you can certainly do so, and you'll even save yourself a little bit of money.

PARTIAL PAYMENTS

• An initial payment of at least 25% of the taxes due, plus any accrued interest, can be made at any time during the collection period. Any payment made on or before February 10th is interest-free. After February 10th, interest accrues at the rate of 1.5% per month.

PAYMENT METHODS

- **ONLINE** To pay with a credit card or online check, please visit www.monroecounty.gov (convenience fee applies). Note that partial payments cannot be made online.
- **BY MAIL** Pay by check or money order made payable to *Receiver of Taxes, Henrietta*. Postmark dates are honored. If you're close to the deadline, walk your payment into the Post Office to ensure it gets postmarked. Please include the payment stub.
- **DROP BOX** Town Hall has an external drop box to submit your payment in a contactless means and after hours, located near the east entrance to Town Hall. Please include the payment stub.
- IN-PERSON AT THE TOWN CLERK'S OFFICE Pay by cash, check, or money order, payable to Receiver of Taxes, Henrietta. Please bring the bill so we can stamp it received and keep the stub.

2023 Dog Park Permits

We are currently selling 2023 dog park permits, which will be valid through 12/31/2023, for \$24 per dog. However, if you registered your dog(s) for the Henrietta Dog Park in 2022 and renew before the end of the year, the renewal fee is **only \$20**. As a reminder, each year you must show a current dog license and rabies vaccination certificate to complete the dog park registration.

Please note that if you wish for your dog park fees to stay in Henrietta, you should renew at the Henrietta Town Clerk's Office or by mailing your renewal forms to us at: 475 Calkins Road / Rochester, NY 14623. Replacement access cards can also be purchased in our office for \$20.


COMPLETING YET ANOTHER RECORD PAVING SEASON

The Highway Department continues to grow its output, laying down 17,000-tons of asphalt, which is a 50% increase over last year's record setting numbers. In addition to repairing Town roads, the crew has also been repairing County roads, which brings additional revenue into the Town to help keep taxes down. This growth was part of a multi-year plan to bring additional employees on to reduce plow times and offset that expense by doing work for the County or State to pay for the additional highway employees.












REDUCING PLOW DAMAGE TO MAILBOXES

Our crews do their best to avoid mailboxes and lawns, but poor visibility, oncoming traffic, and heavy snow loads pulling at the plow, can all lead to plow damage to mailboxes or lawns. In the event we do strike a mailbox, the Town, as a courtesy, will attempt to repair your assembly, or if it is too broken, to replace it with a standard mailbox and post. If your mailbox is struck by a plow, please contact Dispatch at 359-7005. Lawn repairs must wait until the spring, so in late February

or early March, please call to place a work

order for lawn repairs as well.

You can also help reduce the chance of snow plow damage to your mailbox by clearing snow around the mailbox so it is not buried like in the picture above. If your mailbox is at the end of your driveway, you can protect it, as well as reduce the amount of snow pushed back after clearing your driveway, by clearing in the direction the plow is coming from and piling the snow away from the road.





New Sewer Garage Nearing Completion

As the Town has grown, the garage in the DPW building has run out of space. The Sewer and Drainage Department has built a new garage for their equipment, freeing up the space in the DPW building, especially for Highway vehicles used for plowing.

In addition, work continues on the new Facilities Garage, seen in the picture above, which replaced the run-down old garage that used to sit where the new Sewer and Drainage Garage sits. The two new facilities were much needed due to the growth in the Town and the need to be able to respond to storms and other events in a timely fashion.



REPAIRS, MAINTENANCE, AND UPGRADES

Grounds and Facilities did a lot of repairs, maintenance, and upgrades around the Town this year, in addition to all of the mowing, planting, and upkeep on the Town parks, greenbelts, and facilities. This included repairing two of the bridges at Riverton Golf Course, including the one shown left. Crews also upgraded the windows in the Roberts and Bushman cabins and cleared the many dead ash trees out of Hoskins Park as we work towards the creation of the new Educator's Grove being led by a grass roots movement of Rush-

Henrietta alumni. Crews also continued work on the new counter at the Town Clerks Office, creating a wheelchair accessible portion and a better floor to ceiling front for the office. The counters are expected to be installed around the same time this issue hits mailboxes.





WINTER PARKING BAN ALREADY IN EFFECT

This is a reminder that during the winter, parking on the street is prohibited in the Town between the hours of 2:00 AM and 9:00 AM. The ban runs from November 1st to April 15th and any cars found in the road may be ticketed and towed at the owner's expense.

FREE AARP TAX PREPARATION

Building & Fire Prevention

NEW TOWN CODES HELP ACCESSIBILITY

The Town put forth a local law to change the Town Codes with respect to accessibility. Wheelchair ramps and other accessibility elements can now exceed setbacks with just administrative approval needed. In the past, if someone wanted to add a wheelchair ramp and their house was up against the setback, they needed to get a variance, which was a lengthy process, and problematic especially when emergency temporary ramps are needed.





SAFE AND SOUND FOR THE HOLIDAYS

The cold, flu, and covid season is not the only risk for the holidays. Every year, fires break out due to worn power cords, dried trees, decorative candles catching combustibles on fire, or other dangerous holiday practices. When decorating for the holidays, inspect and replace old worn out electronic equipment and components. Be mindful of where you place extension cords; do not run under carpets and if using outdoors be sure they are



approved for exterior use. If you are going to burn candles, locate them away from combustible materials such as curtains, walls and any decorations. Battery operated candles are a safer alternative. Keep fresh cut trees watered and away from heat sources so they don't dry out and become a potential fire hazard.

KEEP WALKS AND STEPS ICE FREE

Keep stoops and sidewalks clear of snow and ice to help prevent injuries, and make sure your driveway and house entrances are kept clear in the event emergency personnel might need to reach you. Be sure your house numbers are clearly visible from the road so that emergency personnel can find your location as quickly as possible; in an emergency, seconds count. Also, please do your best to keep fire hydrants visible and accessible to emergency personnel.





SMOKE AND CARBON MONOXIDE DETECTORS

Change your Clocks; Change your Batteries. A good practice when replacing the batteries is to write the date right on the batteries with a permanent marker for future reference. Some of the newer detectors come with 10-year sealed batteries, which is the typical life span of the detector (check manufacturer's specifications).

BUILDING PERMITS

Building permits are issued to maintain compliance with state and local codes, ensuring life safety and energy conservation. Unfortunately, most codes were implemented as a result of something bad happening in the past. Our job in the Building and Fire Prevention Department is to do all we can to not let the bad stuff happen. 
Engineering & Planning

FILL / GRADING PERMITS

A fill or grading permit is required when you are adding fill to an area or changing the grading of a property. This includes when you want to place the soil material you are pulling up in order to install an inground pool. The reason this requires a permit is the Town needs to ensure you are not accidentally filling in a drainage swale, causing a change in run-off patterns that will negatively affect your neighbors, or creating other potential problems down the road. The permit application is a simple two-page form and does not include any fees.

ARPA FUNDED INFRASTRUCTURE PROJECTS

Phase I of the Lehigh Station Road Sanitary Sewer project is complete and we have designed Phase II and are in the midst of the approval process. Similarly, we have designed the Middle Road Water Main project and are preparing to go out for bid. Both of these projects are receiving some of the American Rescue Plan Act (ARPA) funds – specifically those allocated for infrastructure. In order to accomplish more of these types of projects, we are also creating a Sewer District and a Water District, respectively, to charge a portion of the costs to the residents receiving the benefit. That is how a lot of infrastructure is funded but the nature of these projects would be unaffordable by the charge back method alone since New York State Law dictates the maximum allowable length of debt repayment and there are too few houses to otherwise split the costs. The ARPA funding allows us to do some of these important projects, as does other funding, such as Community Development Block Grants (CDBG).

MIDDLE ROAD TO BE A MAJOR CONSTRUCTION ZONE

In addition to the water main the Town is installing on Middle Road from Lehigh Station Road to the Thruway, the Free Masons of New York are running a sanitary sewer main north from their future facility up to Lehigh Station Road and residents will be able to connect into that. And on top of all of that, the Monroe County Department of Transportation is widening and improving the shoulders and drainage along Middle Road from Calkins Road to Erie Station Road.


GOOD News FOR Seniors and Persons with Disabilities - Higher Income Limits

New York State increased the income limit criteria for certain tax exemptions for seniors and persons with disabilities. Monroe County and the Town of Henrietta adopted the new higher income limits and the Rush-Henrietta Central School District is phasing them in over a three-year span. If you are a senior or person with a disability, please visit the Assessor's Office to see if you now qualify. REAL ESTATE MARKET STILL GOING STRONG

Even as new home builds start to decline and fewer people are selling, demand is outpacing supply. So, houses continue to sell at or above selling price and the overall prices continue to climb, up an average of about 9% from this time last year. This is not the news people want to hear with inflation and other financial concerns, but by keeping Town assessments at full



market value, it avoids our taxpayers being hit with an equalization rate penalty under Real Property Tax Law, which would increase tax rates and lower property exemptions, which is bad for our residents.

UNDERSTANDING REAL PROPERTY TAX LAW

Assessors are governed by New York State Real Property Tax Law (RPTL), which requires that assessments are either kept at full market value or at a consistent percentage of full market value. As stated above, Henrietta keeps them at full market value in order to avoid an equalization rate penalty being levied on our resident's tax bills.

RPTL governs much more that people do not fully understand. We want to educate people on RPTL so as to reduce stress and anger and to help get to a truly fair assessment. The Town gets no additional tax revenue by raising your assessment or no less tax revenue by lowering your assessment. Assessments do not determine how much tax the Town takes in, but instead determines who pays which portion. Our goal is fairness, in compliance with RPTL. So, whatever we can do to help you, we will.

When considering comparable sales, assessors may only look at sales that occurred during a specific time frame, specifically, those sales that occurred in the previous year as close as possible to July 1st of the previous year. And only sales that were an "arm's length deal" may be considered. Sales where the buyer and seller may have a previous relationship, for instance, are excluded. So, for the 2023 Tax Roll, assessed values are equalized to the home real estate market from July 2022 based on the condition of the house on the taxable status date, which is always March 1st of the tax year. Assessors have no flexibility on these laws.

But what they can consider is the selection of comparable properties and the condition of the property. If you are being reassessed, check the list of comparable properties. If you think there are homes more representative of your house in the sales book that the Assessor's Office makes available, stop in and share that. If your house has a significant condition issue, take pictures of it and stop in and share them. Page 14


TOTAL ECLIPSE OF THE SUN

PRECAUTIONS FOR WINTER TRASH REMOVAL

Winter trash and recycling collections present a unique set of challenges not only for residents, but also for the companies and municipalities that provide these services. When winter storms invariably hit, there are a few simple steps that every resident can take to make trash collection easier, more efficient and assure that collection workers return home safely.

- **Keep Bins Out of The Street** set trash and recycling bins off the roadway. Toters placed in the road can be in the way of plows, where they may be pushed aside and damaged.
- Do Not Place Toters or Bins on Top of Snow Piles as they may tip over. Pro tip: If you shovel, clear a small area for your containers. Ask your plow driver to do the same your hauler will appreciate it!
- Retrieve Your Bins ASAP Winter winds can blow empty bins into the street where they present a danger to vehicles. If you are not at home, ask a neighbor to retrieve your containers.
- **Use Trash Bags** Bagging trash prevents items from becoming frozen inside the cart. Additionally, if the cans are blown over, this keeps trash from becoming litter.
- Keep the Lids CLOSED Materials MUST BE LOOSE in the toter.
- **Recycling** See https://www.monroecounty.gov/files/DES/recyclopedia.pdf for a complete list of acceptable items.
- Slow Down Around Garbage Trucks they are big, stop frequently, may have blind spots, and weigh between 20 and 30 tons, so they take twice as long to stop as the average family vehicle and will crush cars in their path.

KEEPING ORGANIC MATERIAL OUT OF LANDFILLS

Much is being written currently about diverting organic materials from landfills. What is included in this category? Food waste is at the top of the list, followed by yard waste such as leaves and brush.

Why are these materials a problem in landfills? Because they emit methane gas as they decompose within the layers of waste without oxygen being available. Methane has more than 80 times the warming power of carbon dioxide over the



first 20 years after it reaches the atmosphere. Even though CO2 has a longer-lasting effect, methane sets the pace for warming in the near term. At least 25% of today's global warming is driven by methane from human actions.

So what other options are available to residents?

- During spring and fall, the Town of Henrietta schedules dates for residents to take yard waste to the drop-off site on Martin Road. These dates are published each year in Henrietta Happenings.
- 2. Grass clippings are not a problem if you use a mulching mower. The clippings decompose on your lawn and provide fertilizer for the grass.
- 3. If you are able, a composter in your yard will take care of most of your food scraps (but not meat or fat). You will get wonderful compost which can be spread on your lawn or gardens. Composters are easy to maintain and information is readily available on-line.
- 4. You can subscribe to Impact Earth Composting and have all of your compostable materials (food scraps, including meat, and paper products) picked up at your home or you can take to them to a drop-off location. Once a year you will receive compost back for use in your garden. For more information go to: ImpactEarthRoc.com
- 5. If you buy a live Christmas tree, you can take it to Tinker Park in January, where it will be turned into chipped mulch for the park trails.
- 6. And looking ahead, the Town of Henrietta is planning a vermiculture food composting site (using worms that do all the work) that will provide a local site for composting of organic materials. Stay tuned for more details to come.

NY STRETCH ENERGY CODE TO TAKE EFFECT IN 2023

NY Stretch Energy Code was adopted by Henrietta in June 2022, with an implementation date of January 1, 2023 in order to give contractors and developers time to adjust to the new requirements. The more stringent building codes for insulation, window quality, and other energy savings measures will benefit new home buyers with lower energy costs and more comfortable houses.

LED STREET LIGHTING PROGRESSING

The Town has initiated the purchase of the existing street lights from RG&E and National Grid. Now the process enters the "bureaucratic phase" as it wades through 150-days of approvals from the utility companies and Public Service Commission. Once approved, Centrica will begin the installation of around 800 new LED streetlights in Town. They have already started with some Town-owned fixtures.
