RESOLUTION #21-291/2022 To adopt SEQR Determination and Issue a Negative Declaration for the proposed Multiple Dwelling Apartment Development Commonly Known as Southridge Landing.

WHEREAS, Dakota Partners, Inc. (the "Applicant") has applied for Special Use Permit No. 2022-008 pursuant to the Henrietta Town Code at Section 295-16[A](10) for the construction of a multiple dwelling apartment building comprising approximately 62 units on a 6.996 +/- acre parcel with a density of approximately 9 units per acre on property at or about East Henrietta Road, Tax Map No. 176.06-2-2.11; and

WHEREAS, the Applicant has also applied for Special Use Permit No. 2022-011 pursuant to the Henrietta Town Code at Section 295-54 and the Town Split-Zone Local Law to acquire a Split-Zone Special Use Permit; and

WHEREAS, public hearings were held on April 12, 2022, June 9, 2022, and September 14, 2022 at public meetings at Town Hall, at which time feedback and concerns from neighbors, residents, and Town Board members were heard and considered; and

WHEREAS, the Town Board has carefully considered all relevant documentary, testimonial, and other evidence submitted, including but not limited to the Special Use Permit application, and other materials and information submitted by the Applicant, any correspondence and oral testimony from the public, State, County, and local agencies, and other information; and

WHEREAS, the Town Board has completed Parts 2 and 3 of the EAF, which are attached hereto, and has carefully considered the information contained therein.

THEREFORE, BE IT RESOLVED, that the Henrietta Town Board hereby approves the attached Part 2 of said EAF.

BE IT FURTHER RESOLVED, that the Town Board hereby finds that the proposal will not have any significant adverse environmental impacts, as more fully set forth herein, in the record, and in Part 3 of the EAF, including in the attachment thereto.

BE IT FURTHER RESOLVED, that the Town Board hereby approves Part 3 of the EAF, confirming its findings in Part 2 of the EAF, and setting forth its basis and reasoning for finding that there are no potential significant adverse environmental impacts.

BE IT FURTHER RESOLVED, that in accordance with its adoption of Part 3 of the EAF, the Town Board hereby issues a Negative Declaration with regard to the action, finding that the proposal will not have any significant adverse environmental impacts.

BE IT FURTHER RESOLVED, that the Town Board hereby directs that the Negative Declaration be filed in accordance with SEQR Regulations, that the Supervisor is authorized to execute such necessary documents and to take such other actions as will facilitate an orderly and proper SEQR process.



1. Impact on Land

Minor impacts, as per the following:

- 1b. A portion of the multi-family development will be constructed on slopes greater than fifteen percent. In these areas, the slopes will be stabilized as soon as possible with jute mesh and other erosion control devices as indicated in the erosion and sediment control plan in order to prevent erosion.
- 1d. The project will result in the excavation of topsoil which may exceed 1,000 tons. The handling of the topsoil will be handled via a Stormwater Pollution Prevention Plan (SWPPP). The stockpiles are temporary and will be stabilized to avoid potential dust and erosion.
- 1e. The construction of the Southridge Landing project will take approximately one year. Construction activities will be phased so that land disturbance and site impact is minimized.

- 1f. A minimum amount of vegetation will be removed from the development area and a buffer will be provided along the existing residential neighborhoods. The existing treed transitional buffer will be protected by orange construction fence to prevent it from being removed or disturbed during construction. Also, a SWPPP will be in place to ensure erosion does not occur. The site will be inspected once or twice per week throughout construction to monitor and ensure the implementation of the SWPPP. Finally, no work will be performed within any NYSDEC protected wetland unless the applicant obtains a permit from the NYSDEC.

2. Impact on Geological Features

No impact; there are no material geological features on or adjacent to the site.

3. Impacts on Surface Water

No significant impacts, as per the following:

- 3a. As part of this project, a new stormwater management facility will be constructed in conformance with New York State Department of Environmental Conservation (NYSDEC) requirements.
- 3d. The action has the potential to create turbidity and sediment in the adjacent water bodies if the proper erosion control devices are not implemented or properly maintained. However, a Stormwater Pollution Prevention Plan (SWPPP) will be used to protect surface water. Additionally, the SWPPP shall use sedimentation basins, stone check dams, stabilized construction entrances, silt fence, and other erosion control devices to control site erosion. Also, site inspections will be performed two times a week if more than five acres of land is disturbed or weekly until the site is stabilized to ensure that erosion is not leaving the site.

No impact; the project is not located within a floodplain.

6. Impacts on Air

No impact.

7. Impact on Plants and Animals

No impact; there are no endangered species located within the project area.

8. Impact on Agricultural Resources

No impact; the project is not located within an agricultural district.

9. Impact on Aesthetic Resources

Minor impact: the land is zoned for senior multi-family developments with the issuance of a special use permit from the Town Board.

10. Impact on Historic and Archeological Resources

No impact; the project is not located within an archaeological sensitive area.

11. Impact on Open Space and Recreation

No impact. This project includes internal and external sidewalks which will improve access within the site and will allow a place for the residents of the proposed community to walk.

12. Impact on Critical Environmental Areas

No, impact; there are no CEA's on or adjacent to the site.

13. Impact on Transportation

No significant impacts, as per the following:

The proposed 62-unit senior living facility will result in a slight increase in traffic along East Henrietta Road and the Calkins Road corridors. Trip generation numbers for the proposed Southridge Landing project were prepared by Passero Associates, PC and incorporated into the "Engineer's Report" which was reviewed by the Monroe County Department of Transportation (MCDOT) and the Town in order to assess traffic impacts.

As indicated in the letter from Brent H. Penwarden III, PE of the MCDOT to Rochelle Bell, Planning Manager for the Monroe County Department of Planning & Development dated April 2, 2022, it indicates that the MCDOT has no comments.

The Fire Marshal would like to have a second entrance for emergency access reasons, and the applicant has revised the site plan so that there is access on all four sides of the building and an adequate area for the emergency vehicles to set up. Also, the entrance for the CVS Pharmacy on Calkins Road can be used as an emergency access if the entrance at East Henrietta Road is blocked.

14. Impact on Energy

No significant impacts, as per the following:

The project will result in the need for additional energy to service the multi-family facility. However, the project will utilize high efficiency appliances and ample capacity is present in the area.

15. Impact on Noise, Odor, and Light

Minor impact; the lighting will be contained on site and not impact adjacent properties. During construction, noise will be kept below the Town's local ordinance levels and time periods. Also, dark sky compliant lighting will be used for the proposed street lights in order to reduce any light shining on adjacent properties.

16. Impact on Human Health

No significant impacts, as per the following:

The site has no environmental conditions which could result in an impact to human health. The proposed use will not generate waste which could impact human health.

17. Consistency with Community Plans

Minor impact; the site is zoned for multi-family residences as long as a special use permit is obtained from the Town Board. Also, there is a day care center located directly south of the project, but an adequate buffer will be provided.

18. Consistency with Community Character

No significant impacts, as per the following. See 17, above.

18b. The project will result in a small demand for community services, however, there is currently ample capacity.
