WHEREAS, Spoleta Construction / 2695 Commercial LLC / La Quinta by Wyndham has applied for Special Use Permits (Application Nos. 2023-006/007) for the construction and operation of an 84 +/- bed hotel, and for a maximum building height of 60 feet (collectively, the "Application"), to be located in a Commercial B-1 Zoned District at Fair Avenue in Henrietta, New York 14467, Tax Map No. 176.05-1-59.23 (the "Property"), or as more particularly described in plans on file in the Town Clerk's Office; and

WHEREAS, a public hearing was duly advertised and held relative to the same; and

WHEREAS, the Town Board has carefully reviewed and considered all documentary, testimonial, and other evidence presented to the Town Board, together with any input from Town staff, other Boards, and other agencies.

THEREFORE, BE IT RESOLVED, that pursuant to the State Environmental Quality Review Act, and in accordance with the EAFs Parts 1, 2, and 3, attached hereto, which are hereby accepted and approved, the Application will not have a significant adverse environmental impact and the Town Board issues a Negative Declaration relative to the Application.

BE IT FURTHER RESOLVED, that the Town Board has considered the Special Use Permit factors and makes the findings relative thereto as set forth on Schedule A attached hereto and made a part hereof, and, based upon said considerations, including all information a part of the record, all materials submitted related to such Application, and reasons discussed at the public meeting related to the same, and so long as compliant with any conditions set forth herein, the Town Board finds that said Special Use Permit factors favor approval of the Application.

BE IT FURTHER RESOLVED, that the Town Board thus approves the Application such that a Special Use Permit for a hotel is approved (pursuant to the Town Code at Section 295-14[B](2)) for a height up to 60 feet (pursuant to the Town Code at Section 295-18), subject to the following conditions:

1. That any further required approvals be obtained, including Site Plan approval from the Planning Board, and any required variances at the Zoning Board of Appeals,
2. That the project uses the existing entrance off of Minerva Campbell Way or, if relocating the entrance, extends the existing sidewalk through the existing entrance being abandoned in favor of the new.

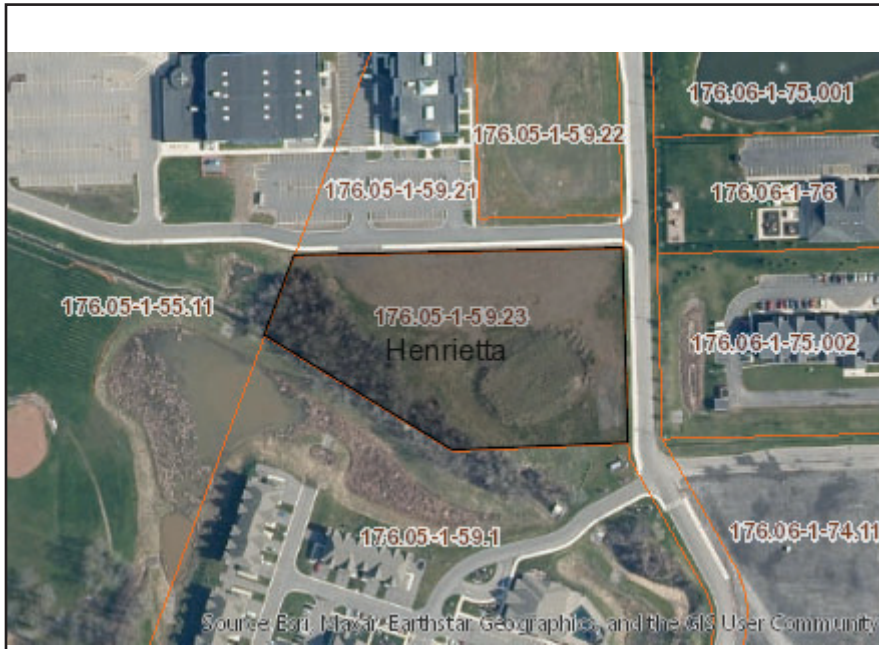

1. Impact on Land

No significant adverse environmental impacts, as per the following:

- 1d. The project will result in the excavation of topsoil which may exceed 1,000 tons, but only during the construction phase of the project. The handling of the topsoil will be handled via a Stormwater Pollution Prevention Plan (SWPPP). The stockpiles are temporary and will be stabilized to avoid potential dust and erosion.
- 1e. The construction of the La Quinta Hotel project will take approximately one year. Construction activities will be phased so that land disturbance and site impact is minimized.
- 1f. A minimum amount of vegetation will be removed from the development area and a buffer will be provided along the existing multi-family residents that are located directly south of this project. The existing treed buffer will be protected by orange construction fence to prevent it from being removed or disturbed during construction. Also, a SWPPP will be in place to ensure erosion does not occur. The site will be inspected once or twice per week throughout construction to monitor and ensure the implementation of the SWPPP. Finally, no work will be performed within any NYSDEC protected wetland unless the applicant obtains a permit from the NYSDEC.

2. Impact on Geological Features

No impact; there are no material geological features on or adjacent to the site.

3. Impacts on Surface Water

No significant adverse environmental impacts, as per the following:

- 3a. As part of this project, a new stormwater management facility will be constructed in conformance with New York State Department of Environmental Conservation (NYSDEC) requirements. This stormwater facility will be a component of the projects SWPPP and contribute to the necessary water quality treatment for the development.
- 3d. The action has the potential to create turbidity and sediment in the adjacent water bodies if the proper erosion control devices are not implemented or properly maintained. However, a Stormwater Pollution Prevention Plan (SWPPP) will be used to protect surface water. Additionally, the SWPPP shall use sedimentation basins, stone check dams, stabilized construction entrances, silt fence, and other erosion control devices to control site erosion. Also, site inspections will be performed weekly until the site is stabilized to ensure that erosion is not leaving the site.
- 3e. See paragraph 3d.
- 3h. See paragraph 3d.
- 3i. See paragraph 3d.

4. Impact on Groundwater

No impact. The project will be served by the MCWA public water supply system and public sewer.

5. Impact on Flooding

The project is located within 100 and 500 year floodplains of a tributary to Red Creek. The finished floor elevation of the proposed hotel is required to be a minimum of two feet above the one hundred year floodplain, and compensatory storage will need to be provided on-site to account for the portion of the floodplain that is being filled in. No development is being proposed within the floodway.

6. Impacts on Air

The proposed project will not include a NYS regulated air emission source as defined by Article 19 of ECL (Environmental Conservation Law) and thus the answer to this question is "no".

7. Impact on Plants and Animals

No significant adverse environmental impacts. The proposed project does not contain habitat for endangered or threatened species, flora or fauna as identified through the NYSDEC EAF mapper. Moreover, the proposed hotel reduces site disturbance as compared to the hotel previously approved at this site in 2019 from 3.8 acres to 3.0 acres.

A minimum amount of vegetation will be removed from the development area and a buffer will be provided along the existing multi-family residents that are located directly south of

this project. The existing treed buffer will be protected by orange construction fence to prevent it from being removed or disturbed during construction.

8. Impact on Agricultural Resources

The proposed project will have no impact on agricultural resources as the project site currently is not an agricultural use.

9. Impact on Aesthetic Resources

The proposed project will have no impact on aesthetic resources, and thus the answer is "no". The project site is not located within five miles of any officially designated and publicly accessible federal, state, or local scenic or aesthetic resource. The proposed use is a hotel which is consistent with the current zoning in that the use is allowed within the zoning district with a Special Use Permit granted by the Town. The magnitude of the hotel development is also consistent with the nearby uses, and is located within a heavily developed and traveled area of the Town.

10. Impact on Historic and Archeological Resources

No significant adverse environmental impacts.

Per the EAF and SHPO mapping, the project site does not contain or is contiguous to known buildings, archeological sites, or districts which are listed on the National or State Register of Historic Places, or that have been determined by the Commissioner of the NYS Office of Parks, Recreation and Historic Preservation to be eligible for listing on the State Register of Historic Places.

While a portion of the site is located within an archaeological sensitive area, the applicant will need to provide the Town with documentation that there are no archeological issues prior to commencing construction.

11. Impact on Open Space and Recreation

No impact. This project includes internal and external sidewalks which will improve access within the site and will allow a place for the residents of the proposed community to walk.

12. Impact on Critical Environmental Areas

No impact; there are no CEA's on or adjacent to the site.

13. Impact on Transportation

No significant adverse environmental impacts since the proposed hotel will only have 84 rooms and will generate less traffic than the original approved proposed use, which was also assessed via SEQR and had no significant adverse environmental impact.

14. Impact on Energy

No significant adverse environmental impacts, as per the following:

The project will result in the need for additional energy to service the hotel facility. However, the project will utilize high efficiency appliances and ample capacity is present in the area.

15.Impact on Noise, Odor, and Light

No significant adverse environmental impacts; the lighting will be contained on site and will not impact adjacent properties. During construction, temporary noise will be kept below the Town's local ordinance levels and time periods. Also, dark sky compliant lighting will be used for the proposed street lights in order to reduce any light shining on adjacent properties.

16.Impact on Human Health

While the proposed hotel is located within 1,500 feet of both a licensed daycare center and a senior living facility, the day care area is surrounded by a fence and the senior living facility is a compatible use. Moreover, the site has no environmental conditions which could result in an impact to human health. The proposed use will not generate waste which could impact human health.

17.Consistency with Community Plans

No significant adverse environmental impacts, as per the following: the site is zoned for a hotel as long as a special use permit is obtained from the Town Board. Also, the proposed hotel is consistent with the scale and mass of the other developments in the Town center area which includes the Town Library, the Town Recreation Center, a senior living facility, and the Dome.

18.Consistency with Community Character

No significant adverse environmental impacts, as per the following: See 17, above.

18b. The project will result in a small demand for community services, however, there is currently ample capacity.

LaQuinta Special Use Permit Assessment by Henrietta Town Board for Proposal on Fair Avenue

§ 295-54 **Granting or denial of special use permits.**

In considering an application for a special use permit, the Town Board shall make its decision based upon the following factors. The Town Board may impose conditions, including in order to resolve any issues identified via its assessment of said factors.

The SEQR assessment for this project, including the EAF Parts 2 and 3 (inclusive of the narrative), are hereby incorporated herein and a made a part hereof, including as the same concerns SEQR as well as all other relevant Special Use Permit factors addressed herein.

- A. Whether the proposed use is substantially consistent in its scale and character with those uses permitted and the existing built permitted uses in the subject zoning district and neighborhood or will otherwise impair such uses due to inconsistency.

In reviewing the application, the use appears substantially consistent in its scale and character as this has been designated as within the “Town Center” with similar scale uses such as the Recreation Center, Town Library, Dome Arena, as well as retail and apartment buildings. The height is taller than the public library, but the proposal sits far enough back that it should not be materially imposing on the street frontage.

- B. Whether the proposed use aligns with the vision, goals and recommendations of the Comprehensive Plan and other applicable plans and studies conducted by or on behalf of the Town.

The 2011 Update to the Comprehensive Plan identified this area as a new “Town Center” and encourages mixed use development, including civic, multi-family housing, retail, restaurants, and similar uses. This proposal is consistent therewith.

- C. Whether the proposed use aligns with the purpose, intent, and applicable design and development standards of the zoning district(s) in which the use is proposed to be located.

The subject parcel is zoned for commercial development, which allows the proposal with a special use permit.

Moreover, the hotel is likely to complement the area, including, for example, by enabling the Dome Arena attract larger acts to the venue, as well as offer the potential to attract other compatible uses, such as restaurant(s). The proposed architectural design meshes well with the surrounding properties in the district.

- D. Whether the proposed use will be a nuisance in law or in fact due to its being materially noxious, offensive or injurious by reason of the production of or emission of dust, smoke, refuse, poisonous substances, odors, fumes, noise, radiation, vibration, unsightliness or similar conditions, or will contaminate waters.

The proposed use presents no nuisance in law or in fact with regards to any of the conditions listed.

- E. Whether the proposed use will create material hazards or dangers to the public or to persons in the vicinity from fire, explosion, electricity, radiation, traffic congestion, crowds, parking of vehicles, or other causes.

The proposed use presents no material hazards or dangers to the public or persons in the vicinity from any of the listed conditions or other causes. The proposed development will be designed in accordance with the Town of Henrietta and appropriate County/State agency standards.

- F. Whether the proposed use will create materially adverse impacts that cannot be adequately mitigated, such as to adversely impact natural resources or the environment, agriculture, community services or other areas required to be addressed by the State Environmental Quality Review Act (SEQRA).

The proposed use presents no materially adverse impacts under SEQR, including as per the SEQR assessment completed by the Town Board.

- G. Whether the physical conditions and characteristics of the site are suitable for the proposed use considering site size, configuration, location, access, topography, vegetation, soils, and hydrology for effective stormwater management and, if necessary, the ability to be screened from neighboring properties and public roads.

The proposed use is suitable for the proposed site and, notably, is even smaller in size than a previously approved use.

- H. Whether there are adequate utilities, public infrastructure, community facilities and emergency services, either existing or to be provided by the applicant or others, to effectively serve the proposed use. A proposed use shall not create or contribute to an existing inadequacy.

The site has sufficient utilities and infrastructure for the proposed use. There is already approval for a traffic light at the end of Fair Avenue that should further alleviate any potential concerns regarding left turns into or out of the Town Center area. The process to install that traffic light is already underway.

- I. Whether the proposed use will provide, maintain, or enhance, as necessary, safe and efficient vehicular traffic patterns, nonmotorized travel, and pedestrian circulation as well as, where feasible, access to public spaces, parks, recreation, and open space resources.

As discussed above, the traffic light being installed at the northern end of Fair Avenue is expected to alleviate any concerns for access into and out of the area. This location is extremely well situated from a non-motorized travel standpoint, and especially with regards to access to public spaces, parks, recreation, and open space resources as it is located immediately adjacent to the Town Library, Recreation Center, Veterans Memorial Park, and Town Hall, as well as the Dome Arena, a Wegmans supermarket and other retail stores and restaurants very close by.
