WHEREAS, the Town of Henrietta received one Incentive Zoning Application and two Special Use Permit applications from GreenSpark Solar, EH Henrietta Solar 1, LLC and EH Henrietta Solar 2, LLC (the "Application"), for the development of a 5 MW AC (Lehigh South Solar 1) and a 1.875 MW AC (Lehigh South Solar 2) Large-Scale Solar Energy Systems on property located between the Lehigh Valley Trail and East Henrietta Road, and directly south of the New York State Thruway, on a portion of land having the Tax Map ID No. 189.02-1-5, (collectively, "the Project"); and

WHEREAS, the Henrietta Town Board has been established as lead agency for purposes of the State Environmental Quality Review Act ("SEQR"); and

WHEREAS, the Henrietta Town Board has carefully considered and taken a hard look at all potential environmental impacts of the Project; and

WHEREAS, the Town Board has completed Parts 2 and 3 of the EAF, which are attached hereto, and has carefully considered the information contained therein.

THEREFORE, BE IT RESOLVED, that pursuant to SEQR, the Town Board hereby adopts and approves the attached Parts 2 and 3 of the EAF.

BE IT FURTHER RESOLVED, that based upon all available information, and after examining the relevant issues, the Town Board hereby determines that the Project will not have a potentially significant adverse impact on the environment, and hereby issues a Negative Declaration.

Brief Description of Proposed Action (include purpose or need): The proposed projects are ground-mounted photovoltaic solar arrays that will be located at tax parcel 189.02-1-5. Project 1 is a 6.626 MW-DC, 5 MW-AC array, and Project 2 is a 1.726 MW-DC, 1.425 MW-AC array. The projects will be owned by EH Henrietta Solar 1 LLC and EH Henrietta Solar 2 LLC, respectively, under a lease agreement with Lehrwood Estates LLC, c/o Bruce Howlett. The projects will be constructed and operated by Sustainable Energy Developments, Inc, D.B.A. GreenSpark Solar. The arrays will have separate points of interconnection to the Rochester Gas & Electric utility grid, with Project 1 having approximately 12,272 modules, and Project 2 approximately 3,198 modules on a ground mounted, pier driven racking system. In total, the two proposed arrays would occupy approximately 32.03 acres of the 55.38 acre parcel, with an additional area of approximately 1.33 acres of access road outside the fence line (extending into tax parcel 189.02-1-1.1 via an access easement). Ground disturbance would be limited to the pier driven posts of the racking system, the electrical trenches, parking/staging area, and the fence line. The power generated by the project is intended for Community Solar Array off-takers through a net metering agreement.

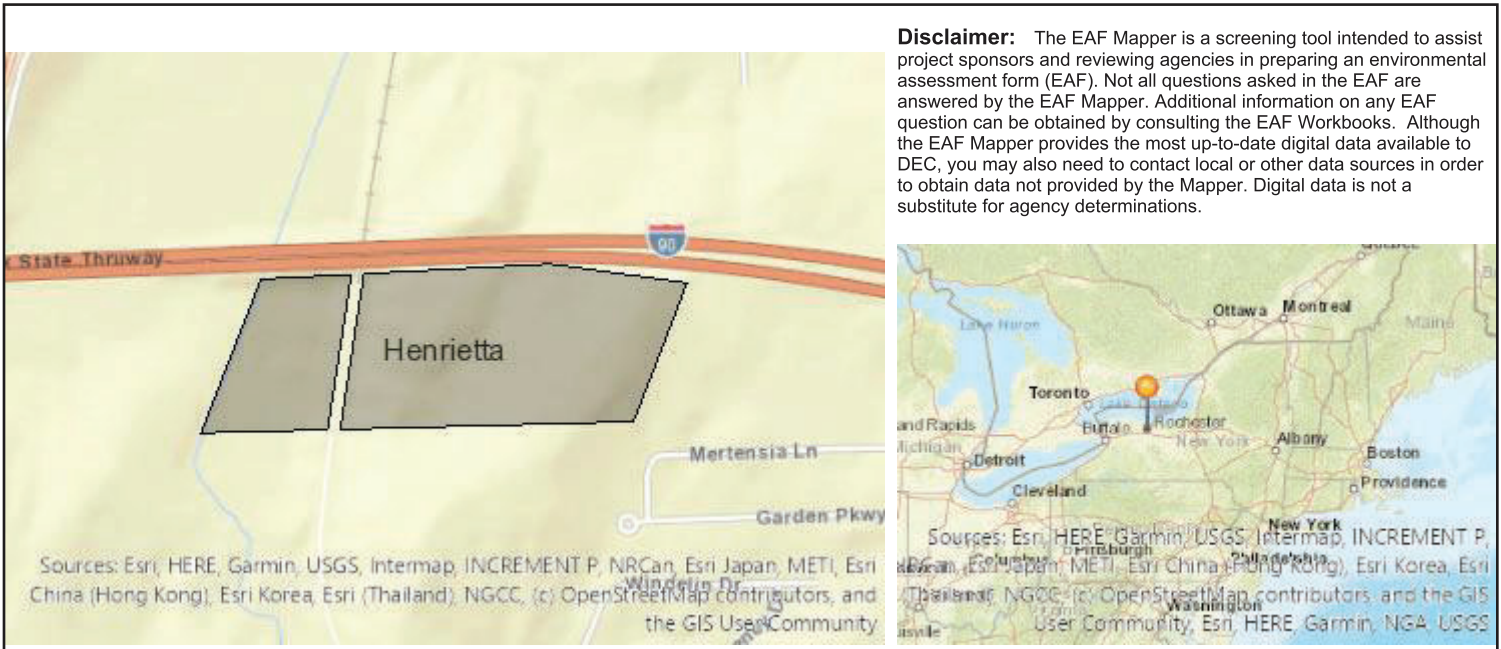

1. Impact on Land

The existing land was part of a former golf course that was abandoned and has remained unfarmed. The impact will be low since the land has been previously disturbed.

Generally, the installation of the solar panels is accomplished with little overall ground disturbance, as panels are driven into the ground and may be removed. Upon removal of solar facilities, the land occupied by the solar array can be utilized again, and the land is required to be restored to its pre-installation state. Thus, no irreversible are anticipated.

- 1f. If the site requires any earthwork, then a grading plan will be in required to ensure that erosion does not occur. The site will be inspected once a week throughout construction to monitor the condition of the erosion control until ground cover has been established. Additionally, the impact on the land will not be permanent, since, per the Town Code, and as secured by financial security and a decommissioning plan, the solar facilities will be required to be removed at end of life.

2. Impact on Geological Features

No impact; there are no geological features on or adjacent to the site.

3. Impacts on Surface Water

- 3e. The action has the potential to create turbidity and sediment to the surrounding drainage system if the proper erosion control devices are not implemented or properly maintained. A stormwater pollution prevention plan and grading plan (SWPPP) was provided since more than one acre of land is disturbed. The SWPPP will be prepared in accordance with the New York State Department of Environmental Conservation and Town of Henrietta standards. The grading plan will have to use sedimentation basins, stone check dams, stabilized construction entrances, silt fence, and other erosion control devices to control site erosion. Also, site inspections will be performed once a week until the site is stabilized to ensure that erosion is not leaving the site.

Also, per the Town's wetland map and the wetland and watercourse delineation report, there are NYSDEC and Federal Wetlands located within the site. No disturbance to these wetlands will be permitted without a permit from the NYSDEC and the Army Corps of Engineers.

Also, a creek crossing will be required for this project in order to access the site. No such crossing will be permitted without a permit through the NYSDEC and the Army Corps of Engineers. In addition, the work on the culvert or bridge will be kept to a minimum so that a natural creek bottom is maintained and there is limited disturbance to the riparian buffer.

4. Impact on Groundwater

No impact; the project will not use or impact the groundwater, and the conditions/operation and maintenance plan aims to protect against any potential contaminants that could be introduced to the groundwater.

5. Impact on Flooding

- 5b. A portion of the site is located within the 100 year and 500 year floodplain, and the floodway of the East Stem for Red Creek. No buildings or structures are proposed within the 100 year floodplain. If any grading is proposed within the floodplain, then the applicable Town procedures & requirements will need to be followed as indicated in

Chapter 125 of the Henrietta Town Code. A drainage culvert or bridge may be constructed within the floodway.

6. Impacts on Air

No impact.

7. Impact on Plants and Animals

No impact, per Part 1 of the Full Environmental Assessment form, there are no endangered species, flora, or fauna located within the project area.

8. Impact on Agricultural Resources

Generally, the installation of the solar panels is accomplished with little overall ground disturbance, as panels are driven and will be removed. Upon removal of solar facilities, the land occupied by the solar array can be utilized again, and no irreversible impacts are thus anticipated. In addition, to the extent applicable, the Projects will require compliance with the Department's Guidelines for Agricultural Mitigation for Solar Energy Project.

- 8a. The project site is not located within a Monroe County agricultural district, but is located adjacent to one. The proposed use will not create any materially adverse impacts that cannot be mitigated. While the panels will displace some low-value open space that used to be a golf course, the panels will not be in the areas of the adjacent farm that contain the high-value agriculture. In addition, the proposed use will plant native plants including nitrogen fixers and pollinators so as to restore the soil underneath the panels. As a result, when the arrays are removed, the soil will be better for agricultural use than it is today. Also, an Agricultural Data Statement was provided for this project.
- 8c. If the proposed project results in the compaction of the soil, then soil decompaction will be required to a depth of eighteen inches and by using a tractor mounted deep ripper or a heavy-duty chisel plow.
- 8d. See paragraph 8a.

9. Impact on Aesthetic Resources

No impact, there are no scenic or aesthetic resources in the vicinity of the site. However, the natural screening from woods and topography will mean that the solar arrays will be adequately screened from adjacent properties. The least amount of screening is along the northern exposure of the solar arrays, however in that direction the project is bounded by the New York State Thruway (NYS Route I-90). The projects will not be in the viewshed of any residences or businesses.

Also, screening such as pine and spruce trees can be provided along the east side of the Lehigh Valley Trail in order to provide a "green" landscape buffer between the trail and the solar array.

10. Impact on Historic and Archeological Resources

- 10c. Since the site is located within an area designated as archeologically sensitive, a Phase IA Cultural Resource Investigation may be required. The applicant will have to provide

documentation to the Town and to the New York State Parks, Recreation, and Historic Preservation (OPRHP) stating that there are no archeological issues prior to commencing any construction work.

11. Impact on Open Space and Recreation

Low impact. The subject lands are not used for recreation, and the open space will be preserved given that the facilities will be removed at end of life. The natural screening from woods and topography will mean that the solar arrays will be adequately screened from adjacent properties. The least amount of screening is along the northern exposure of the solar arrays, however in that direction the project is bounded by the New York State Thruway (NYS Route I-90). The projects will not be in the view-shed of any residences or businesses.

The entrance for solar facility will cross the Lehigh Valley Trail which is a linear Monroe County Park. The crossing will be performed per Monroe County requirements and will provide another point for residents to access the trail. Also, additional parking will be provided and landscaping can be planted to provide a buffer between the trail and the solar array.

12. Impact on Critical Environmental Areas

No impact, there are no CEA's on or adjacent to the site.

13. Impact on Transportation

No impact. Little or no traffic will be generated by this project.

14. Impact on Energy

No impact, there is ample energy capacity present in the area. Also, the solar energy facility will benefit the community by generating up to 6.85 megawatts of renewable energy.

15. Impact on Noise, Odor, and Light

Minor impact; during construction, noise will be kept below the Town's local ordinance levels and time periods. After construction, the use is generally very low impact relative to noise and light, and generates no odors.

16. Impact on Human Health

No impact. The proposed use will not create any materially noxious, offensive, or injurious issues. The only potential contamination would be due to the deterioration of abandoned solar panels. Because the code requires a decommissioning bond or escrow to fully cover the removal and proper disposal of the solar panels, even that potential has been mitigated. Also, the proposed use as a solar facility will not generate waste that would impact human health.

17. Consistency with Community Plans

No impact. The Update to the Comprehensive Land Use Plan, adopted January 2019, added large scale solar arrays up to 25-acres to be installed on working farms as part of the code changes suggested in the Farmland Protection Plan that was adopted in the spring of 2018. A full GEIS was conducted as part of the Comprehensive Land Use Plan and saw that by allowing

these solar arrays on working farms, it would help preserve agriculture in Town by providing auxiliary farm income. As part of the recommendations from the Farmland Protection Plan, Comprehensive Land Use Plan Update, and associated GEIS, the arrays would be installed in a manner that minimizes agricultural impacts on the working farms and that revitalizes the soil lying under the arrays. Even though the proposed solar arrays are not located within an active farm, they are located in an area where the same are otherwise allowed, and thus are consistent with the character and plans for the area. Moreover, the proposed use meets the intent of the standards dictated in those plans and studies and preserves open space, is consistent in scale and character with those solar facilities that are permitted in this zoning district, and, except for being located on an active farm (as approved via incentive zoning), the facilities will comply with the special use permit requirements applicable thereto.

Additionally, per the incentive zoning application, the Proposal will result in a bandshell that will benefit the community.

18. Consistency with Community Character

No impact. The proposed use preserves open space (including since the installation is not permanent), is consistent in scale and character with those solar facilities that are permitted in this zoning district, and, except for being located on an active farm (as approved via incentive zoning), the facilities will comply with the special use permit requirements applicable thereto. It generates little to no traffic, noise or light, and no odors. Also, the project will result in no demand for community services.
