



# Tax Levy vs Tax Rate

- The Tax Levy is the sum total of how much we collect in property taxes
- The Tax Rate is the Tax Levy divided by the Total Assessed Value of Taxable Properties in Town and is generally expressed as an amount per \$1,000 of assessed value
- So, for instance, if you have a \$4-Million tax levy and \$4-Billion in taxable properties, then the Tax Rate would be \$1 per \$1,000 of assessed value

#### Real Growth versus Total Growth

- Real Growth in the Town is due to new construction or enlargements or improvements of existing properties.
- Total Growth includes the Real Growth as well as the growth due to increases in assessed values.
- For this year, the real growth is 2%, which is what it has been for a number of years now.
- The total growth is 5%, so 3% of that is due to rising house prices.

# When do Taxes Increase?

- Politicians love to claim they didn't raise taxes. What they generally mean is they didn't raise the Tax Rate.
- But when you hold the Tax Rate flat, you ARE increasing taxes if any portion of the Total Growth is due to rising assessments.
- If you only increase the Tax Levy by the amount of the Real Growth, then you are truly holding taxes flat.

# 2020 Projected Special District Rate Changes

Drainage – Tax levy remains the same for an estimated decrease of \$0.18/unit

Sewer – Tax levy remains the same for an estimated decrease of \$0.26/unit

#### 2020 Preliminary Budget Distribution

The 2020 Tentative Budget was distributed to the Town Board on September 25, 2019. Based on feedback and updated numbers from benefit providers, small adjustments were made. During the October 9, 2019 Town Board Meeting a presentation was delivered on the Tentative Budget.

The Preliminary Budget was forwarded to the Town Clerk on October 16<sup>th</sup> in advance of the Public Hearing.

Addressing needs for the Town with additional positions:


Highway: +2 To help with plowing and paving Building and Grounds Maintenance: +1 To help with mowing Engineering: +1 To help redesign drainage system
