

RESOLUTION #15-167/80

On motion of Councilman Murphy, seconded by Councilman Klein,
WHEREAS, pursuant to Resolution #7-87/80 adopted by the Henrietta Town
Board on March 19, 1980, the public hearing was duly held at the
Henrietta Town Hall at 475 Calkins Road, Henrietta, New York on April
16, 1980 for the purpose of considering , and hearing all persons

interested in, the adoption of an Ordinance amending Article IX of the Henrietta Zoning Code, entitled "Historic Sites", and
 WHEREAS, at such hearing all persons interested in the said ordinance, both in favor of and opposed to, were given an opportunity to be heard, and

WHEREAS, after due consideration the Town Board finds that the adoption of the following Ordinance is in the best interest of the Town of Henrietta,

RESOLVED, that the following Ordinance be and it hereby is adopted:

ORDAINED BY THE TOWN BOARD OF THE TOWN OF HENRIETTA:

1. Section 127-33 of Article IX Historic Sites of the Henrietta Zoning Code entitled Hisoric Sites Committee be and it hereby is amended to read: The Committee shall be comprised of seven (7) members, one of whom shall be the Town Historian. Members shall be appointed by the Town Board for terms of four (4) years.

2. Section 127-34, D (1) of Article IX Historic Sites of the Henrietta Zoning Code entitled Demolition regulations for historic sites, Approval or Disapproval be and it hereby is amended to read: A project that has received Town Board approval will be issued a demolition permit.

3. Section 127-35, D (1) of Article IX Historic Sites of the Henrietta Zoning Code entitled Alterations, modifications or new construction, Approval or Disapproval be and it hereby is amended to read: A project that has received approval will be issued a building permit and construction begun under the regulations set forth under Chapter 6, Building Construction Administration (Revised Code Chapter 31, Building Construction), of this Code.

4. Section 127-35, Appendix A of Article IX Historic Sites of the Henrietta Zoning Code be and it hereby is amended by adding thereto the following:

APPENDIX A

Each of the following sites is hereby designated a Historic Site.

- a. The property owned by the YMCA of Rochester, located at 3044 East Henrietta Road, Tax Account No. 242-000.
- b. The property owned by Harold R. Kruchten & Wife, located at 3146 East Henrietta Road, Tax Account No. 237-000.
- c. The property owned by William Buckley, located at 3204 East Henrietta Road, Tax Account No. 232-000.
- d. The property owned by Edward H. Swift, located at 3112 East Henrietta Road, Tax Account No. 230-000.
- e. The property owned by Marie Swift, located at 3224 East Henrietta Road, Tax Account No. 229-000.
- f. The property owned by Thomas J. Fitzpatrick & Wife, located at 3236 East Henrietta Road, Tax Account No. 228-000.
- g. The property owned by the Church of the Good Shepherd, located at 3286 East Henrietta Road, Tax Account No. 225-000.
- h. The property owned by Justin Knowles, located at 3306 East Henrietta Road, Tax Account No. 224-000.
- i. The property owned by Philip Winslow & Wife, located at 3490 East Henrietta Road, Tax Account No. 360-000.

j. The property owned by William Tyler, located at 3495 East Henrietta Road, Tax Account No. 391-000.

k. The property owned by Carl W. Johnson, located at 3081 East Henrietta Road, Tax Account No. 260-000.

l. The property owned by Clifton Wright, located at 3031 East Henrietta Road, Tax Account No. 254-000.

m. The property owned by James T. Burger & Wife, located at 1670 Lehigh Station Road, Tax Account No. 289-000.

n. The property owned by Nelson Abeel, located at 1689 Lehigh Station Road, Tax Account No. 288-000.

o. The property owned by John Howland & Wife, located at 1710 Lehigh Station Road, Tax Account No. 271-000.

5. This Ordinance shall take effect immediately.
