

RESOLUTION #9-112/83

On motion of Councilman Murphy, seconded by Councilman Breese,
WHEREAS, pursuant to Resolution #2-22/83 adopted by the Henrietta
Town Board on January 5, 1983 the public hearing was duly held at the
Henrietta Town Hall at 475 Calkins Road, Henrietta, New York on
February 2, 1983 for the purpose of considering, and hearing all
persons interested in, the adoption of an Ordinance amending Article
IX of the Henrietta Zoning Code, entitled "Historic Sites", and
WHEREAS, at such hearing all persons interested in the said Ordinance,
both in favor of and opposed to, were given an opportunity to be
heard, and

WHEREAS, after due consideration the Town Board finds that the adoption
of the following Ordinance is in the best interest of the Town of
Henrietta,

RESOLVED, that the following Ordinance be and it hereby is adopted:

ORDAINED BY THE TOWN BOARD OF THE TOWN OF HENRIETTA:

1. Article IX of the Henrietta Zoning Code, entitled Historic
Sites be and it hereby is amended by adding to Section 127-35.1 A

We tried to put it in once before and the owner at that time was trying to sell it. The property as you can see was built in 1830 and Manning is doing a super job and we're very proud of you.

On behalf of Harold and Doreen Manning, this is very much appreciated. Especially that Hal Manning is a retired school teacher. He started his teaching career on East Henrietta Road in the old Academy, right across the street from this present building that he now owns. So again, on behalf of them, thank you very much.
