

RESOLUTION #14-225/85

WHEREAS, pursuant to Resolution #24-415/84 adopted by the Henrietta Town Board on December 19, 1984, a public hearing was duly held at the Henrietta Town Hall, 475 Calkins Road, Henrietta, New York on January 16, 1985 for the purpose of considering, and hearing all persons interested in, the adoption of an ordinance amending Article IX of the Henrietta Zoning Code, entitled "Historic Sites", and
