From The Supervisor

Winter 2016



Dear Residents,

As we enter into the New Year many things are happening!

We broke ground on the Recreation Facility in early November. The Town Department of Public Works (DPW) crew will be doing all of the site work for construction. This will add up to a lot of savings for the tax payers. The site work was led by Foreman

Marshall Wright and equipment operators Wasyl Gudselack, Tim Lessing, Craig Barber, Larry Harper, Rob White and Tim Briggs.

As of the December 2nd 2015 Town Board meeting, foundation and steel bids for the Recreation Center will be released. If we have a mild winter you may see steel frame work going up in early March, with a possible completion date early in 2017. We all can't wait!

The Library will have a much needed new heating and air conditioning system installed early 2016 replacing an aged 35 year old system.

We will also start construction on new restrooms on the west side of the Veteran's Memorial Park property. Town DPW will be responsible for roofing and all of the interior work. Completion is scheduled for early 2016.

Additional development in the Town includes redevelopment of the Dome Center, with increased seating and a complete renovation from top to bottom by FSI Construction. The remainder of the Town Center project will be the construction of 122 high end apartments at the south end of the Dome property by Morgan Development & Spoleta Construction.

Along East Henrietta Road (Rte 15A) there will be 3 beautiful townhouse projects constructed. On the East side of 15A, between Stone Wood Village and Goodburlet Road will be an attractive project consisting of 77 units by Morrell Builders. Barbary Cove is a 72 unit project to be located along the Lehigh Valley Trail on the West side of 15A and 33 unit Trail View South will be placed on the East side of 15A just north of the Rush town line.

On the West Side of Town, the old Kodak building will be brought back to life by the Rainaldi family. Renovations include 360,000 square feet of office and tech space. The north side of the property will be the future home of a 600 bed student housing complex with construction planned for spring of 2016 and open by fall of 2017.

The DPW has prepared for the winter season with snow fence installation and vehicle preparations. We are also excited to present the new 2015 Mack plow truck featured below. DPW employees voted on changing the town plow truck colors from safety yellow to bright blue cabs with stainless steel bodies. The stainless steel bodies require less maintenance and have great longevity. Even after 15 to 20 years the truck bodies can be transferred to new truck cabs, and again, saving the Henrietta taxpayers money down the road. Thanks go out to our DPW vehicle maintenance team: Foreman Ron Laracca, Josh Marshall, Jay Shoots and Larry DeNoto for putting the new truck together...great job!

From the Town Historian

Henrietta United Church of Christ - Celebrating 200 Years in 2016

Early settlers often held religious services in their homes. One group of worshipers who would become the Congregational Church, met in a school house in 1816 that was located near James Sperry's home on Methodist Hill. Moses Sperry would read sermons he received from his former pastor. Rev. Solomon Allen from the First Presbyterian Church of Pittsford would occasionally preach to the group as well.

On February 10, 1818, the early church members voted to become the Manville Religious Society and Moses Sperry, Henry Chapman and Linas Evarts were elected trustees. A log meeting house was built near the center of town on Middle Road. Members of the religious society provided supplies and labor instead of cash to assist in the building of the meeting house. This is an example from an old record book:

John Gooding by boards for meeting house	\$21.95
John Gooding for shingle nails	1.69
John Gooding on two gallons of whiskey on M.H.	.50
John Bales by 4 days on meeting house	2.00
Warren Burr 1 ½ days masoning	1.00
(as written in logbook)	



Land was purchased from the Monroe Academy trustees in 1831 for \$250 and in 1832 a frame church and horse sheds were built on Lehigh Station Road. This would have been the church attended by Antoinette Brown Blackwell, who became the first woman ordained as a minister in the United States. On Saturday, January 26, 1867, a fire occurred which quickly swept through the building. Furniture was saved by people from the town. There was no insurance and the loss was estimated at \$2,500. Three days later, during a special meeting held in the Monroe Academy, the church members decided to accept the invitation from the Methodist Episcopal Church to share their building** until a new church could be completed. The name of the church was changed to the First Congregational Church of Henrietta. A cornerstone for a new church was placed on the site of the old church on August 6, 1867.

The church congregation continued to increase and in 1966 a new building was constructed on the site of a barn on the former Buyck Farm at 1400 Lehigh Station Road. The former church building was taken down and a two story apartment building is located on that site today. To meet the needs of families with two working parents, a child care operation was sponsored by the congregation from 1978 to 1999.

The year 2013 brought more construction as the building was renovated to provide expanded meeting space, handicapped accessibility at all entrances and other improvements to the existing structure. The bell from the former church had been kept and on November 6, 2013 was placed in a bell tower above the main entrance.

Special programs and a banquet are being planned for this spring.

In 1916, the congregations of the Methodist Episcopal Church and the First Congregational Church joined to form the Union Congregational Church. A kitchen and fellowship hall were added to the building during the 1940s. From 1947 to 1950, the church rented space to the Rush Henrietta Central School District while the new centralized school was built on East Henrietta Road. The school cafeteria was in the kitchen; the 8th grade met in the primary Sunday School room; the Art Department was located in the basement; and the home making classes used the Guild Room and the kitchen.

What you need to know about paying your taxes

2016 COMBINED TOWN & COUNTY TAX COLLECTION

Tax bills were mailed to real property owners on December 31st. If you are responsible for payment and have not received your tax bill by January 8th, please call (585) 359-7035 to request a duplicate bill at no charge or by visiting www.monroecounty.gov.

As a reminder, we honor postmark dates so if it is close to the deadline, make sure you walk your payment into the Post Office to ensure it gets postmarked. We do NOT honor "postage meter" marks. Payments can be made at the Town Clerk's Office by cash, check, or money order; please make all payments payable to "Receiver of Taxes, Henrietta". To pay with a credit card (3% convenience fee applies), please visit www.monroecounty.gov.

**The deadline for both first installments AND full payments is:
Wednesday, February 10th!**

For complete payment information, please visit www.henrietta.org and click on "Tax Information" under the Quick Links on the right hand side.

INFORMATION ON TAX RECEIPTS

In an attempt to keep costs down, the Town of Henrietta does not automatically mail a receipt for all received tax payments. The law states that we must mail receipts to property owners with accounts held in escrow, but do **not** need to mail a receipt **UNLESS IT IS REQUESTED** for accounts not held in escrow. There is a small checkbox on the bottom left of the tax bill that you should check to request a receipt. **A tax receipt will only be mailed if this box is checked off or if the account is held in escrow.**



However, we ask that you consider assisting in our efforts to control costs and to help the environment by NOT checking the box and, instead, obtain your payment information online through the Monroe County website at www.monroecounty.gov by clicking on "View/Pay Taxes Online." If you then click the "pay property taxes" button, you will have an option to view the tax history and/or payment history. As always, if you are unsure about what to do, we encourage you to call us at 585-359-7035.

HENRIETTA DOG PARK

The Henrietta Dog Park located in Lookup Park has been extremely successful since it opened 18 months ago. We are currently selling 2016 dog park tags, which are \$24.00 per dog for the calendar year. If you registered your dog(s) for the Henrietta Dog Park in



2015, you should have received renewal forms in the mail from us that can be returned either by mail or in person. Remember, you do not have to be a resident of Henrietta to use the Henrietta Dog Park, so encourage your friends to register their dogs and join you! Each year you must show a current dog license and rabies

vaccination certificate in order to complete the dog park registration. Membership to the Henrietta Dog Park will allow you to use all 4 dog parks in the Monroe County Dog Park system, including the brand new park in the Town of Sweden, using the same pass code. DOG LICENSES

For your added convenience we can now notify you via email, in addition to the renewal postcard sent in the mail, regarding your annual dog license renewal. If you submit your renewal by mail, please include your current email address and we will add it to our database.

DID YOU KNOW?

The state surcharge fee included in your annual dog license goes directly to the Department of Agriculture and Markets and is transferred to the ASPCA who then gives out 100% of the money in grants for spay and neuter programs.

The Engineering Department

Our New Recreation Center

The Town of Henrietta's Engineering Department is pleased to announce that we have taken on the task of site design services for Henrietta's new Recreation Facility! This task is outside the usual duties of this department. Normally, this department is busy reviewing new construction work within the Town limits, (72 current projects) along with designing smaller scale projects for our parks and facilities. The current site plans for the Recreation Facility will include all of the work needed outside the building. Site plans depict the area of proposed construction operations, which includes parking, utilities, drainage, landscaping and lighting.

The town has hired the consultation firm of Passero Associates to design the building for the Recreation Facility. The Town Engineering department is working internally to develop the site plans. The Department of Public Works will add its expertise to perform a portion of the site work with our staff. Although this isn't the process for every town, it's ideal for Henrietta because we not only get to utilize the vast experience of our full time engineers that worked both in the private and public sectors, we also get to use the experience of our interns and give them a deeper understanding of both sides of the design process.

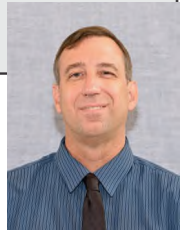
The Town of Henrietta management had the forethought to hire engineers with both public and private design experience. By using the capabilities of these experienced engineers we are able to save approximately \$50,000 to \$70,000 by performing this work with our current staff.

This isn't the end of keeping big projects in house; it's really just the beginning. In 2004 when Henrietta updated the Comprehensive Land Use Plan a goal was made to create a Town Center. The Town Center is basically an area of land in which there is an inviting environment where residents have easy access to town facilities. Next on the list is a new Town Library.

Winter Reminders

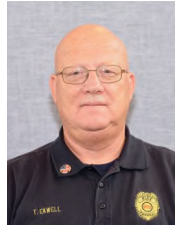
It's important to keep your driveway and sidewalks clear of snow and ice for your safety and that of any emergency personnel if the need arises. Also, don't forget to shovel out those neighborhood fire hydrants.



For those of you that have a woodstove or fireplace, make sure to keep the flu clear and burn only seasoned firewood. It's a good idea to have them professionally cleaned at least once a year, more often for heavy use.

Winter is a great time for planning home projects for when the weather breaks. Building permits may be required. We issue permits to ensure safe construction whether it's a new deck, addition or installation of a hot tub or whole house generator. Please call the Building Department or view the town website for required residential permits. We will be happy to assist you with project questions and permit needs.

The Assessment Office

The principal function of the Assessor's Office is to maintain a fair and equitable assessment roll, which is the basis for the property taxes you pay. This assessment roll is prepared every year, by analyzing real estate market conditions and maintaining property ownership records. We are currently in the process of compiling the 2016 assessment roll.

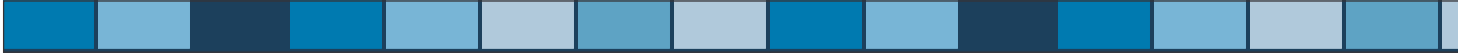
Watch your mail for renewal applications for any property tax exemptions you may have. Many exemptions do not automatically renew from year to year and require annual renewal. If you currently have a renewable exemption, the Assessor's office will be mailing individual renewal applications to you in January which must be returned by March 1, 2016.

If you are a new homeowner, and have not done so, you should make your one-time application for the Basic STAR anytime between now and March 1, 2016. Basic STAR exemptions do not need annual renewal with our office. If you are turning age 65 during the year 2016, you might qualify for even greater tax savings with the Enhanced STAR, or the Limited-Income Senior's Exemption.

Don't forget: all exemption applications, whether new or renewals, must be returned by **March 1, 2016!**

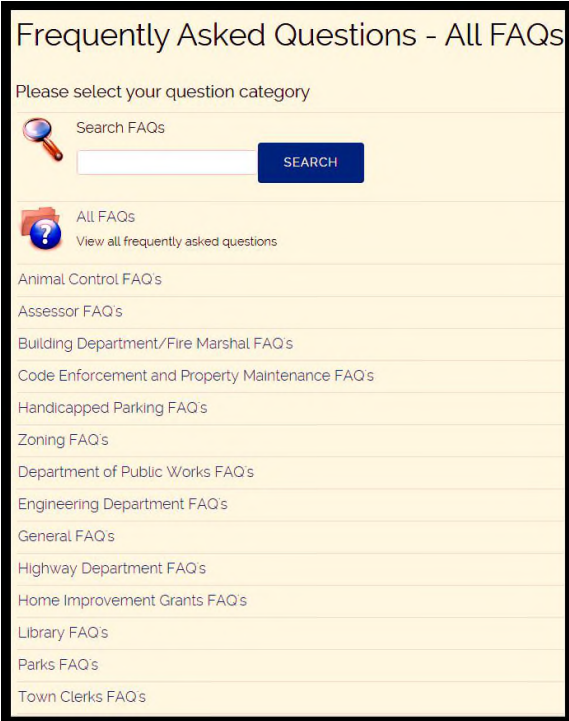
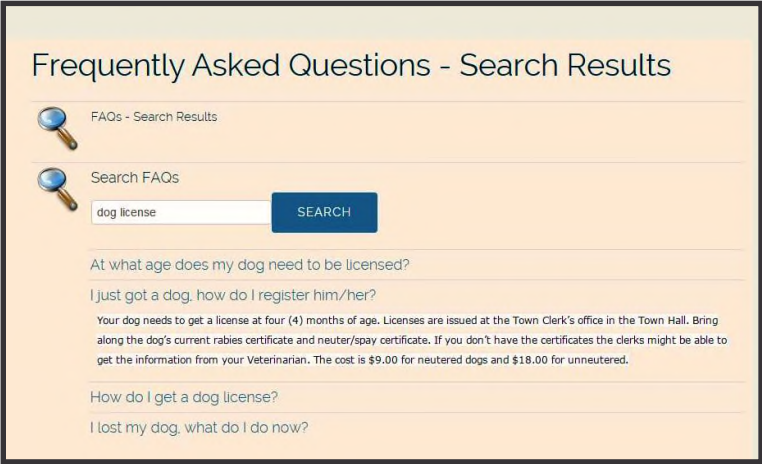


What Are FAQ's?

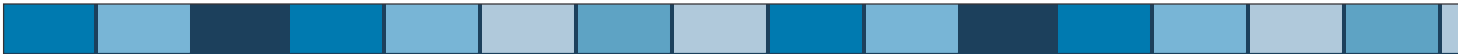
There are many “Frequently Asked Questions” at the Town of Henrietta. On our website, we have compiled a listing of these popular inquiries.

Department of Public Works

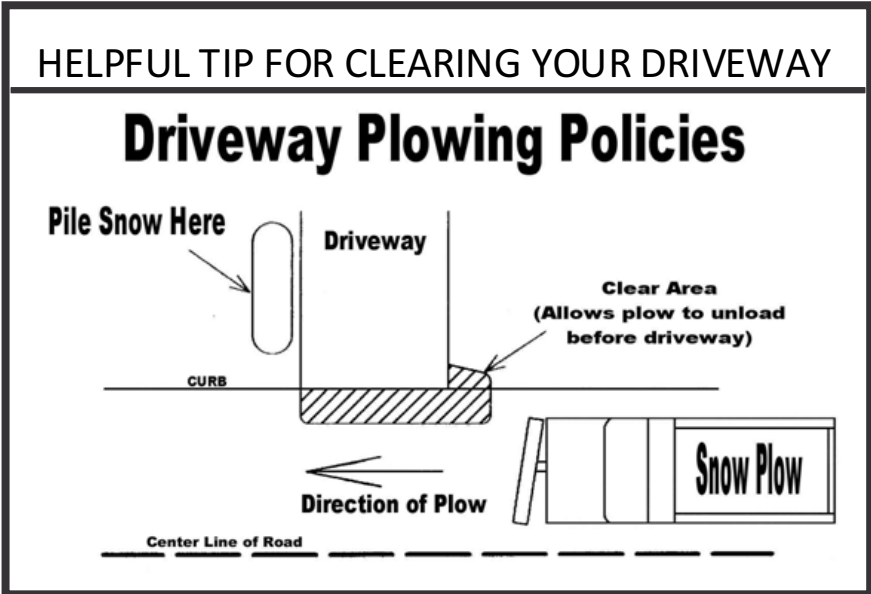
Daylight is getting shorter every day, a sure sign that winter is here. Winter's ice and snow bring ever-changing challenges to drivers, pedestrians and our Public Works employees. Henrietta's Public Works Department is second to none when it comes to addressing the onslaught that winter hands out each year. We do our very best to create safe passable roads, sidewalks and parking areas during and as soon as the storm is over however, we need your help as well. Keeping snow out of the street when clearing driveways, using the correct speed for the road conditions and not parking in the street overnight are just a few ways to help us help you.

We are all responsible to help improve water quality. Residents can assist in that task by effectively using de-icing materials on their driveways and walks. The Town of Henrietta uses sensible salting guidelines put together by the County's Environmental Council on our roadways. A preset application rate is used to control ice and snow and at the same time protect the water in creeks and streams. Residents should use just enough of these materials to make their areas safe and in doing so you can help improve water quality.

The winter season and its snow offer many opportunities for children and adults alike to build things in the snow. Sometimes the snow piled up at the end of driveways and along the street makes desirable spots to play in. These spots are especially dangerous due to the operation of snow removal equipment and traffic in general. Please discourage your children from playing in these areas for everyone's safety.

The following may be useful for some residents when clearing your driveway. It may help your driveway to stay clear even after plows have gone by.

Please allow adequate distance between you and the plow equipment and please, DO NOT attempt to pass this equipment. Our staff is trying to clear the roadway and may make abnormal maneuvers in their attempt to clear snow and place salt.
